

**Rocky Mountain Health Plans Web Portal User Agreement
Terms and Conditions of Access and Use**

PLEASE READ THESE TERMS AND CONDITIONS OF USE CAREFULLY BEFORE USING THIS SITE. Access and use of this Web Portal is subject to compliance by you with the terms and conditions set forth herein.

1. **NATURE OF SERVICE.** Rocky Mountain Health Plans (RMHP) has developed a Web Portal to provide access to certain records and information maintained by RMHP. Remote access is to be provided through the internet via a secured, password protected computer interface.

2. **COPYRIGHT MATTERS; FEDERAL AND STATE HEALTHCARE LAW COMPLIANCE.** The contents of the Web Site, such as text, graphics, images, and other materials ("Material") are protected by copyright under both United States and foreign laws. Unauthorized use of the Material may violate copyright, trademark, and other laws.
