## **Update to RMHP Group Service Agreement**

RMHP is adding a provision to the Group Service Agreement to be compliant with Colorado House Bill 06-1343. This House Bill enacts measures to ensure that illegal aliens do not perform work on a public contract for services. The new contract provision will be included in the Group Service Agreement for all new groups enrolling with RMHP beginning March 1, 2007. Since this regulation affects only public entities, GSA amendments will not be issued to all existing employer groups. If you have current clients who are public entities that are subject to the requirements of HB1343, you or your client may request the new contract provision from RMHP by calling the Group Management Team at 800-453-2981 (Option 1).
