If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your deductible?	Yes. <u>Preventive care</u> , primary care and <u>specialist visits</u> , <u>prescription drugs</u> , labs, x-rays, and <u>urgent care</u> , child eye exams and child dental check-ups are covered before you meet your <u>deductible</u> .
