2022 Individual and Family Benefit Modifications and New Plan Offerings

Hello, Valued Brokers!

Rocky Mountain Health Plans is excited for the 2022 Open Enrollment Period and plan year ahead. You will find competitively priced health plans for your clients through RMHP, all administered locally in Colorado.

We will be mailing our Annual Benefit Modification notices to enrolled Individual and Family Members this week.

Changes to existing plans for 2022 include minimal benefit changes by plan and the following:

- **All Plans** (*sample Rocky Mountain Valley letter*)
 - **Change in Preventive Prescription Drug Tier:** All individual and family plans will place preventive prescription drugs separately on Tier 1 – available at no cost. These preventive drugs are currently available at no cost, but are included in other drug tiers. Placing all preventive prescription drugs on Tier 1 shifts the Tier reference for all other drugs to create a 6-tier drug benefit for 2022.
 - **Urgent Care:** Urgent care for Behavioral Health and Substance Use disorders will have no cost sharing in 2022 for all Non-HSA Plans.
- **Monument Health Plans** (*sample letter*)
 - **New Prescription Drug Formulary:**
 - Monument Health plans will be transitioning to a new prescription drug formulary in 2022. The Essential Plus 6-tier formulary is narrower than the current Advantage 4-tier formulary, still providing access to prescriptions our Members need. Your clients' prescriptions may have changed coverage tiers with this new formulary and there may be new limitations, changes in days'-supply and new exclusions.
 - RMHP will send letters to all Monument Members impacted by the change in the new formulary in November. To assist in understanding this new coverage and to compare and search for prescriptions under the new Essential Plus formulary, RMHP will have a link to Optum Rx available soon.



- **Colorado Doctors Plan** *(sample letter)*

- **New Preferred Pharmacy Benefit:**

- Colorado Doctors Plan Members will have a new preferred pharmacy benefit that lowers the cost of Tier 2 drugs to \$3 when obtained at a preferred pharmacy. All Walgreens in Colorado are preferred pharmacies.
